The undersigned natural persons of the age of eighteen (18) years or more acting as incorporators under the Oregon NonProfit Corporate Law adopt the following Articles of Incorporation:

ARTICLE 1

The name of this corporation is UMPQUA VALLEY LEAGUE OF WOMEN VOTERS, and its duration shall be in perpetuity.

ARTICLE 2

The purpose, or purposes for which the corporation is organized are:

To promote political responsibility through informed and active participation of citizens in government.

ARTICLE 3

The address of the initial registered office of the corporation is 741 S. E. Kane Street, P. O. Box 2479, Roseburg, OR 97470, and the name of its initial registered agent at such address is Alice Lackey.

ARTICLE 4

The mailing address to which the Secretary of State may mail notices as required by ORS Ch. 61 is P. O. Box 2479, Roseburg, OR 97470.

ARTICLE 5

The number of directors constituting the initial executive board of directors of the corporation are three (3), and the name and addresses of the person's who are to serve as directors until the next annual meeting, or until their successors are elected and shall qualify are:

#### ARTICLE 6

The board of directors shall consist of the officers of the League, six (6) elected directors, and not more than six (6) appointed directors. Three (3) directors shall be elected by the general membership at each annual meeting and shall serve for a term of two (2) years, or until their successor have been elected and qualified. The elected directors, in the manner provided in the bylaws of the corporation, shall appoint such additional directors, not exceeding six (6), as they deem necessary to carry on the work of the League. The terms of office of appointed directors shall be one (1) year and shall expire at the conclusion of the fiscal year in which they are appointed.
